



# M0021-2D: ISPS Awareness

## Training Description and Objectives:

For most terminals the PFSO and Security are mostly well informed about the International Ship and Port Facility Security (ISPS) Code. However, it is important that also other staff knows what ISPS is about, what – and most off all why – measures are taken and what procedures are in place to ensure the security of the port facility and the ships mooring there.

This is a two days course and it is vital for Operations and Commercial Management Teams which deal with risk management and security precautions. ISPS Awareness also makes it possible for the delegate to have a clear understanding and awareness of the Code as well as implement it for providing the most efficient and safe security management and its strategies which make let finding solutions to the toughest problems at short notice.

## Training Designed for:

This course is intended for supervisors, port facility managers, logistic and commercial managers, emergency service managers, crew of the ship, security staff in ports and other technical personnel.

## Training Requirement:

**“Hand’s on practical sessions, equipment and software will be applied during the course** if required and as per the client’s request.”

- ❖ Different security levels and the applicable procedures
- ❖ Specific tasks of participants present: what do they need to report and how (*preferably supported by examples that occurred at the terminal*)
- ❖ Alarm and evacuation
- ❖ Drills
- ❖ Practical Exercises
- ❖ Course Conclusion
- ❖ POST-TEST and EVALUATION

## Training Methodology:

ISPS training course includes ISPS/SOLAS relations, counter terrorist profiling, security information, access control along with perimeter security, security treats, etc. At the same time the training program comes along with all necessary material including CDs, course materials, ISPS Code book and many other useful additions.

This interactive training course includes the following training methodologies as a percentage of the total tuition hours:-

- 30% Lectures, Concepts, Role Play
- 70% Workshops & Work Presentations, Techniques, Based on Case Studies & Practical Exercises, Software & General Discussions
